The freedom of choice by the Forum organizers in the elaboration and execution of an educational program must be maintained, even when total costs for that program are borne by industry.</li> <li>Industry may not offer payments to Forum attendees to cover travel, accommodation or honoraria, nor may attendees accept payments if offered.</li> <li>Industry may not organize any functions involving Forum registrants that will conflict with any educational sessions or global social events. Industrial promotions should enhance the activities of the Forum and never interfere with the official program. Industry functions which are strictly social in nature will not be facilitated or recognized by the Canadian Surgery Forum.</li> <li>The recognition of industry partnership must consist only of acknowledgement of the support of the firm or firms but not of individual products except in the case where a commercial exhibit has been arranged.</li> </ol>
